TERMS & CONDITIONS – GROUP LESSONS

1. The Delta Community Music School is a not-for-profit organization which undertakes to provide the schedule of instructions set out on the registration form.
2. **A NON-REFUNDABLE DEPOSIT** covering Membership (per family) of \$10.00 (as stated in the Society Act) and a registration fee of \$10.00 is payable at the time of registration. These fees are paid annually. Please note that this is an administration charge and apart from tuition is the only additional fee that we require. Unlike other schools, we do not charge for participation in recitals or for providing the services of an accompanist.
3. **FEES** are payable in advance for the year either in full or in two equal installments dated 1st September and 1st January payable to "Delta Community Music School or DCMS" and are due and payable upon registration. Lessons will be suspended for those students whose accounts are in arrears. **CHEQUES MUST BE DEPOSITED WITH THE SCHOOL BEFORE THE STUDENT BEGINS CLASSES. ALL NSF CHEQUES WILL BE CHARGED A \$26.00 HANDLING FEE.**
4. Enrolment is only accepted from those returning students whose fees and accounts are paid up to date and in good standing. Any arrears must be paid in full before subsequent enrolment is accepted.
5. **All members are encouraged to participate in some form of fundraising efforts throughout the year** either individually or at fundraising events.
6. **REFUNDS** will be made **ONLY** if the school cancels the course of study for any reason **OR** in the event of the student's serious illness.
7. Due to the continuous nature of **GROUP LESSONS**, missed classes cannot be made up.
8. Withdrawals will only be accepted in the first 4 weeks of classes. **IN THE CASE OF WITHDRAWAL, TWO WEEKS NOTICE (15 DAYS) MUST BE PROVIDED AND WILL NOT BE REFUNDED.**
9. Delta Community Music School Membership fees and registration fees are **NOT** refundable.
10. **MATERIALS** such as music books, metronome and instruments are chosen at the Instructor's discretion.
11. Participation in recitals and other Music School events both as a member of the audience and as a performer is greatly encouraged.
12. The School accepts no responsibility for personal injury occurring at any School activity (including transportation to and from the activity) nor for any damage to instruments or personal property, however caused.
13. **ALL MONIES COLLECTED AS A RESULT OF PERFORMANCES OR PRODUCTION OF A DEMO CD** WILL BE CONSIDERED FUNDRAISING EVENTS FOR DELTA COMMUNITY MUSIC SCHOOL. NO STUDENT WILL RECEIVE MONETARY REIMBURSEMENT FOR SUCH ACTIVITIES UNLESS AUTHORIZED IN ADVANCE BY THE BOARD OF DIRECTORS. THE BOARD OF DIRECTORS' DECISION WILL BE FINAL.
