INFORMED CONSENT FOR IN-SCHOOL ACTIVITY DURING COVID-19 PUBLIC HEALTH CRISIS

This document contains important information about our decision (yours and ours) to resume operations in light of the Covid-19 public health crisis. Please read this carefully and let us know if you have any questions. When you sign this document, it will be the official agreement between you and the Delta Community Music School (DCMS).

Decision to Enter the Music School **Employee, Volunteer, Other** (Please Print) _____.

We have agreed to open the school on a limited basis. If there is a resurgence of the pandemic or if other health concerns arise, however, we may require closure again. If you have concerns about aspects of our operations, we can discuss it with you first and try to address any issues. Please understand that if we believe it is necessary, we may determine that we cease operations indefinitely.

Risks involved

It is understood that by coming to the school you are assuming the risk of exposure to the coronavirus (or other public health risk). This risk may increase if you travel by public transportation, taxi, or ridesharing service.

Your Responsibility to Minimize Your Exposure

You agree to take certain precautions which will help keep everyone in the school including yourself and your family safer from exposure to the coronavirus. If you do not adhere to the safeguards, it may result in the school reverting to on line lessons. Please initial each of the statements below to indicate you understand and agree to the actions:

- You will only enter if you are symptom free. _____
- You agree to have your temperature taken on arrival. If your temperature is abnormal you agree to leave. _____
- You will wash your hands or use approved hand sanitizer when you enter the school building. _____
- You will adhere to the safe distancing instructions that are set up in the school. _____
- You will wear a mask while in the school where required. _____
- You will have no physical contact with anyone while in the school or immediately outside the school. _____
- You will try not to touch your face or eyes with your hands. If you do, you must immediately wash or sanitize your hands. _____
- You will immediately contact the school personnel if you become exposed to someone who is infected whether in or outside your home. _____

These precautions may change from time to time if additional Local, Provincial or Federal guidelines or orders are published. If that happens, we will advise you.

Confidentiality

If you have tested positive for the coronavirus, we may be required to notify local health authorities that you have attended the school. If we have to report this, we will only provide the minimum information necessary for their data collection. By signing this form you are agreeing that we may do so without additional permission from you.
